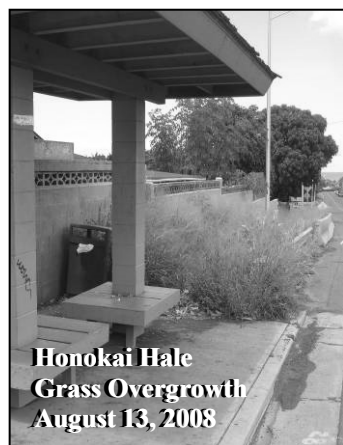
Challenger Center Hawaii Safe for Now



You might have heard in the media that JV sports were recently at risk of being cut by the Board of Education (BOE). However, you might not have known that the Challenger Center Hawaii (CCH), located on the campus of Barbers Point Elementary, was also on the chopping block. I was happy to testify at the August 7th BOE meeting in support of keeping the \$255,732 in the budget for this very important educational program.

If you're not familiar, a unique public private partnership came together in 1993 to launch the CCH. The CCH is one of only 50 such programs in the United States, Great Britain, Canada, and South Korea. It has allowed over 73,000 public and private students from middle schools from across the state to gain first hand knowledge about the workings of a mission control room, modeled after NASA's Johnson Space Center, and a Space Station. I commend the BOE for giving both JV sports and the CCH another look before going forward with the budget cuts.

Business Steps Up to Cut Overgrowth in Honokai Hale

Expanded Bus Service for Kaupe'a Community

I was recently contacted by a Kaupe'a resident who was concerned about having to walk from her home to catch TheBus at Kama'aha Avenue and Kapolei Parkway. We wrote the City to see if they would consider providing better bus service for this new residential community, located off Kapolei Parkway between Kapolei High and Middle schools.

I was very happy to receive letters from the Department of Transportation Services on July 18th and July 28th announcing that as of August 25th, Route F13 would have expanded service for the Kaupe'a community. TheBus will go in a clockwise loop using Kama'aha, Puainako, Kapolei Parkway, and back to Kama'aha. A big mahalo to Mayor Hannemann and DTS Director Wayne Yoshioka for improving bus service for the people of Kapolei!



Improved Lower Campus Lighting for Waikele Elementary

I was happy to learn that the Department of Education is moving forward with a project to improve exterior lighting for the lower campus at Waikele Elementary School.

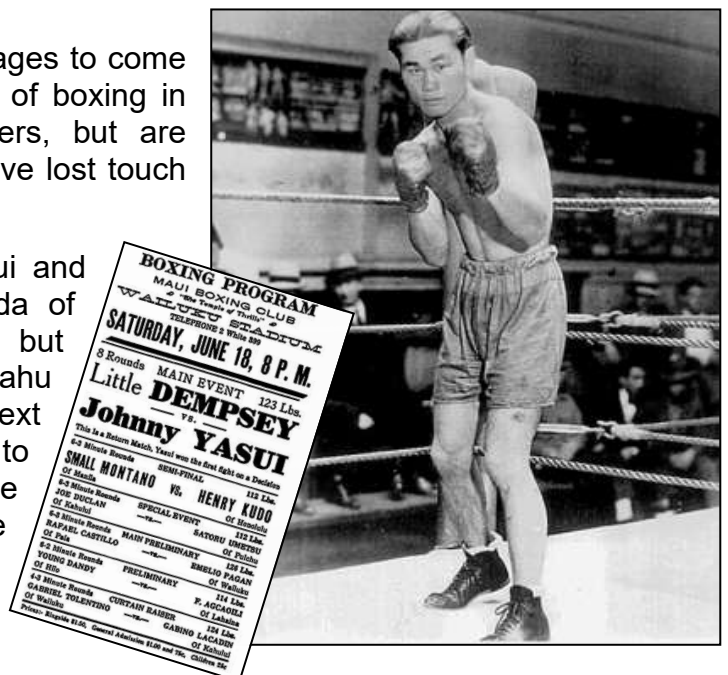
Old Timers Boxing Club

Time for Hawaii to Become Telework Leader

A pilot project in the state Department of Human Resources for a 4-day work week? It's about time! This makes perfect sense as our soaring gas prices and traffic congestion take their toll on everyone in Hawaii. It's a good first step in getting people off our roads and allowing them to spend more time with their families. But we can do much more!

In 2006, Sperling's Best Places ranked Honolulu 8th in the nation among medium-sized metropolitan areas for the potential benefits that teleworking could offer our residents. If you're not familiar, teleworking frees up government and private sector employees to work from home or whatever location they choose. Studies have shown that teleworking decreases traffic, improves people's health and well-being, increases productivity, and allows people to spend more quality time with their families.



We've looked at this issue before, but our past efforts have been inconsistent and short-lived. When I took office as a state senator in November 2006, I started researching whether we could improve our quality of life by encouraging government and businesses to allow their employees to work from home. For almost 20 years, Arizona has been a leader in teleworking. They have an office dedicated to fulfilling a state mandate which requires all of their departments to participate in a telework program.




So in 2007, my office consulted with experts in Arizona to craft Senate Bill 698. My bill would have directed the DOT to be the lead agency in coordinating and implementing a 1-year pilot workplace flexibility program for state employees. It would have required that four state agencies have, at a minimum, 10% of their workforce choose a workplace flexibility option, including telework, compressed work weeks (4 – 10-hour work days or 9 days on and 1 day off), or adjusted work schedules (flextime).

The International Telework Association and Council estimates that 16% of U.S. residents worked at least once a week from home in 2006. A group that gives work-at-home job advice called Undress4Success.com has put together some interesting statistics concluding that only 4.3% of Hawaii residents work from home.

Using government data from the EPA, the federal Department of Transportation, the US Census, and several other sources, Undress4Success.com finds that another 36% of Hawaii residents have jobs conducive to working at home. They estimate that an average Hawaii worker could save 231 gallons of gas annually and have \$1,009 more in their pockets. They also estimate that we would be able to save 55 million gallons of gas each year. Their findings show that on a national level, if roughly 40% of people in our country who have jobs that are a good fit for teleworking were doing so, we could reduce Gulf Oil imports by 74% and gas consumption by 12.3 billion gallons a year. These numbers are amazing!



 It doesn't make sense to be living in paradise, but always stressed out about spending all our time in our cars. In the coming months, I'll be talking to people and working with my colleagues at the Capitol on ideas for legislation for 2009. I'm convinced that the time is now for Hawaii to become a telework leader!
